

2017 Utility Rates

Rates originally increased in 2010 due to the results of a Comprehensive Utility Rate. Since this study, the City has made a concentrated effort to look at the needs of the Utility to determine how utility rates could be stabilized while continuing to meet financial obligations, comply with legal requirements, maintain level of service, and adhere to industry best practices. As a result of this effort the city was able to approve a rate structure for 2014-2018 that is significantly lower than they were approved to increase to as set into place by the 2010 study.

The base water usage will decrease by one unit per year from 2014-2018, allowing residents the power to lower bills by conserving water. For 2017 the base usage decreases from 7 units to 6 units.
